I am directed to inform you that an assessment to verify the compliance submitted by the college authorities on the deficiencies pointed out in the assessment report (8th & 9th August, 2018) to assess the physical and the other teaching facilities available for continuance of recognition of MBBS degree (100 seats) granted by Guru Gobind Singh Indraprastha University in respect of students being trained at Army College of Medical Sciences, Delhi was carried out by the Council's Assessors on 26th August, 2019. The compliance verification assessment report (26th August, 2019) alongwith the summary/observations of the member of the UG Expert Group was considered by the Board of Governors and it was decided to recommend that recognition of MBBS degree granted by Guru Gobind Singh Indraprastha University in respect of students being trained at Army College of Medical Sciences, Delhi be continued restricting the number of admission to 100 (one hundred) students, subject to documentary evidence/undertaking of rectification of deficiency of (1x800 mA X-ray machine and Lecture Theatre).

The Board of Governors also decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April, 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable

for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute....."

It is further to inform you that your institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material etc. throughout, as stipulated in Regulation of Medical Council of India.
